# **5. NYSRC 2010 Reliability Compliance Monitoring Program**

## **5.1 2010 Compliance Monitoring Program Summary**

Mr. Adamson reviewed the updated 2010 Compliance Program Summary and referred to October assessment results that were included.

## **5.2 NYISO Operations Report for October 2010**

Mr. Grant reviewed the Operating Report for October 2010 with RCMS. Based on its review, RCMS found the NYISO in full compliance for K-M2d for October 2010.

## **5.3 Pre-seasonal Fault Duty Assessment (E-M6b)**

RCMS reviewed a NYISO self-certification for E-M6b that was updated to reflect recent SOAS and OC actions. Based on its review, RCMS found the NYISO in full compliance with E-M6b.

## **5.4 Certification That LSE ICAP Obligations Have Been Met (A-M3)**

RCMS reviewed a NYISO certification that found that all LSEs have met their ICAP obligations for the November 2009 to October 2010 period. Based on its review, RCMS found the NYISO in full compliance with A-M3.

## **5.5 Review of December 2010 Compliance Assessments**

The following measurements will be assessed in December: C-M11, G-M1, G-M2, G-M3, G-M4, I-M5, and I-M6.

## **6.0 NYSRC Procedure for NYCA Transmission Reviews**

Mr. Adamson reported that RRS had no comments on the Procedure and agreed to include it as an Appendix in the RR Manual. The EC will be requested to approve the Procedure at tomorrow's meeting.

## **7.0 Compliance Template Manual Revision**

The EC will be requested to approve the revised CT Manual at tomorrow's meeting.

## **8.0 Policy 4 Revision**

Mr. Adamson reported that he did not receive comments from RCMS members on proposed revisions to Policy 4. He will begin to revise the policy accordingly. He expects to have a complete draft by March 2011, with some sections available for RCMS review before then (**AI #130-1**).

## **9.0 Market Participant Violations of NERC Standards**

Mr. Adamson reviewed a table summarizing past NY market participant violations of NERC standards. RCMS agreed to discuss the summary at tomorrow's EC meeting, and ask for direction from the EC as to future RCMS efforts in this area.

## **10.0 Plan for NYSRC 2011 Reliability Compliance Program Preparation**

Mr. Adamson reviewed proposed steps for preparing the NYSRC 2011 Compliance Program, as follows:

- Prepare a list of proposed 2011 assessments, including the reasons they were selected. To be reviewed by RCMS on December 2 (**AI #130-2**).
- Prepare a initial "2011 Scorecard" without compliance documentation requirements and milestone dates. To be approved by RCMS on January 6, with EC review on January 7.
- Meet with NYISO staff late in January to discuss compliance documentation requirements and due dates.
- Prepare complete 2011 Scorecard draft for RCMS approval on February 11 and EC approval on February 12.

### **11.0 PRRs #104 and #106**

Mr. Adamson discussed the status of PRRs #104 and #106. These PRRs are on tomorrow's EC agenda with RRS recommendations to adopt and to post for comments, respectively. Mr. Kiernan had comments on C-M1 changes in PRR #104. Mr. Adamson suggested that he discuss his comments with Mr. Clayton before tomorrow's EC meeting.
