## 1. Peter Carney Presentation

Mr. Peter Carney started the presentation announcing that RGGI released at 8 am the bidding rules.

Mr. Carney then proceeded to summarize the white paper. The following are the highlights of his presentation:

- The first sub-regional allowance auction is now scheduled for September 25, 2008. This auction will offer 6.7% of 2009 allowances; however, none from New York State. Mr. Carney expressed his concern about price disruption because the lack of liquidity in the market. He believes that the market would not be fully involved until sometime in 2009.
- It was clear from his presentation that RGGI initial auctions would not have an impact on the NYCA generating fleet in 2009; however, the ICS will perform a sensitivity analysis to analyze RGGI impact for which the ICS needs the necessary information by October 1<sup>st</sup>.
- NYISO announced that it was using Gridview, a production cost simulation program, to measure the NYCA generation fleet change in fuel consumption as a consequence of RGGI. The group asked for the assumptions made in this model and the NYISO will present them on a Conference Call scheduled on August 4<sup>th</sup>, 2008.
- Mr. Carney also updated the group saying that on July 11, 2008, The United States Court of Appeals for the District of Columbia Circuit vacated the United States Environmental Protection Agency's (USEPA) Clear Air Interstate Rule (CAIR). NYSDEC State Implementation Plan (SIP) to achieve compliance with National Ambient Air Quality Standards (NAAQS) for ozone has been based on this approach that included the United States Environmental Protection Agency's (USEPA) Clean Air Interstate Rule (CAIR). This means that the NYSDEC will have to submit another SIP (CAIR, HEDD, and NOx-Rack) to address O3 standards and that SIP will not have an impact on NYCA resources in 2009.
