**4.3** 2023-32 Long Term Resource Adequacy Assessment [A.3: R2] –

Mr. Clayton reviewed the A3:R2 Self certification document. Ms. Popa presented the NYISO's 2022 NYSRC Long-Term Resource Adequacy Assessments presentation. Mr. Adamson asked about additional risk factors not listed in presentation. Ms. Popa replied these listed in the presentation are only major risk factors or policy drivers, this is not an exhaustive list, the full list is in the report. Mr. Adamson asked if the report include the risk factors and mitigation actions. Ms. Popa replied that on an ongoing basis they monitor and include all presented risks.
