## 2.0 Approval of Minutes/Action Items

## 2.1 RCMS Draft Minutes #196

Meeting minutes were approved with minimal changes. Mr. Clayton made a request that future meeting minutes include "Draft" in the header of future first drafts.

#### 2.2 RCMS Action Items List

Action Item 196-1. Al Adamson proposed what he called a compromise solution to last session's impasse on the subject of requirement G.4(R2). He suggested putting the requirement onto future versions of the Scorecard as an annual item. Jim Grant disagreed, and Dan Head reminded the group that it was because of this disagreement that the Action Item was added in the first place. RCMS came to no consensus, which is why the matter was being pushed to RRS.

Roger Clayton and Mr. Adamson both argued that the scope of the change in question did not rise to the level of a rule change and proposed changing the wording of the requirement to ensure that the NYISO checks with Con Edison on an annual basis as to whether or not a new Blackstart Study is or will be required due to changes on the bulk

power system. Mr. Clayton then asked Mr. Head to take this back to Con Edison's Transmission Planning section to see if this change was minor enough to pass without going to RRS (Action Item 197-1).

With the PRR passed through RRS, the NYSO now has thirty days to clarify under what conditions it can/will declare ETC.
