## 3.0 NYSRC 2017 Reliability Compliance Monitoring Program

3.1 2017 Reliability Program Update

No update other than updating requirements approved last month.

- 3.2 July Operations Report (C.8: R1)

  The NYISO submitted to RCMS the July Operations Report certifying full compliance with requirement C.8 (R1) for July 2017. Mr. Clayton noted that the peak load for July was 29,699 MW, well below the NYCA all-time summer peak load of 33,956 MW.

  There were only 2 emergency transfers declared in July. RCMS found the NYISO in full compliance with requirement C.8 (R1).
- 3.3 List of NYS BPS Facilities (B.3: R1 to R3)

  The NYISO submitted to RCMS the documentation certifying full compliance with requirement B.3 (R1 to R3), citing the NPCC Criteria Document A-10 Classification of Bulk Power System Elements for developing a list of NYS BPS Facilities. The BPS Facilities List is classified CEII. RCMS found the NYISO in full compliance with requirement B.3 (R1 to R3).
- 3.4 NYISO Requirements for Con Ed Operating Procedures (G.1: R1, R2, R4, R5) The NYISO submitted to RCMS the NYISO documentation certifying full compliance with requirement G.1 (R1, R2, R4, and R5), citing the NYISO Transmission and Dispatching Manual Section 2.1.6 and Con Ed procedures. Mr. Clayton had one comment on the justification for claim of full compliance without having seen the referenced Con Ed procedures. The Con Ed procedures are confidential and the NYISO has reviewed the procedures. RCMS agreed that the procedures have been reviewed in the past and RCMS found the NYISO in full compliance with requirement G.1 (R1, R2, R4, and R5).
- 3.5 NYISO Requirements for Con Ed Operating Reserves (G.1: R3, R6)
  The NYISO submitted to RCMS the NYISO documentation certifying full compliance with requirement G.1 (R3 and R6), citing the NYISO Emergency Operations Manual Section 4.4.1 and Con Ed procedures. RCMS found the NYISO in full compliance with requirement G.1 (R3 and R6).
- 3.6 Con Edison Operating Procedures and Reserves (**G.1:** R7)
  The NYISO submitted to RCMS the NYISO documentation certifying full compliance with requirement G.1 (R7), citing several Con Ed procedures. RCMS found the NYISO in full compliance with requirement G.1 (R7).
- 3.7 Con Edison Loss of Gas Supply (**G.2:** R1)

  The NYISO submitted to RCMS the NYISO documentation certifying full compliance with requirement G.2 (R1), citing Con Ed procedures. Mr. Grant noted that for G.2: R1 to R.2 are related to PRR-138 and that any changes made for LIPA should be changed for Con Ed. RCMS agreed and had planned to apply the changes from PRR-138 to Con Ed, as well. RCMS found the NYISO in full compliance with requirement G.2 (R1).
- 3.8 NYISO Requirements for Con Ed Loss of Gas Facilities (**G.2:** R2)
  The NYISO submitted to RCMS the NYISO documentation certifying full compliance with requirement G.2 (R2), citing the NYISO Transmission and Dispatching Manual Section 2.1.6. RCMS found the NYISO in full compliance with requirement G.2 (R2).
