### 3.0 NYSRC 2018 Reliability Compliance Monitoring Program

#### 3.1 2018 Compliance Monitoring Program Update

#### 3.2 July and August 2018 Operating Reports

NYISO submitted to RCMS the July Operations Report certifying full compliance with C.8 (R1) for July 2018. August 2018 Operations Report will be provided when available. No emergency declaration was reported. RCMS found the NYISO in full compliance with requirement C.8 (R1) for July 2018. Motion by Mr. Head and seconded by Mr. Shanahan.

#### 3.3 NYISO Requirements for Con Edison Operating Procedures [G.1: R1, R2, R4, R5]

Con Edison provided procedures and studies to the NYISO and NYISO stated they are in full compliance. NYISO provided Operations Manual 12 and referenced Con Edison Procedure S00326N System Operations with Day Ahead and Con Edison Procedure S005-02-19 Thunderstorm Procedure. RCMS found the NYISO in full compliance with requirement G.1: R1, 2, 4, 5 for 2018. Motion by Mr. Shanahan and seconded by Mr. Gordon. Copies of Con Edison procedures will be requested for RCMS later in meeting.

#### 3.4 NYISO Requirements for Con Ed Operating Reserves [G.1: R3, R6]

NYISO provided report and are stating they are in full compliance. This requirement concerns ten minute reserves and NYISO provided an Emergency Operations Manual 15 excerpt and Con Edison Procedure S00326N. RCMS found the NYISO in full compliance with requirement G.1: R3, 6 for 2018. Motion by Mr. Head and seconded by Ms. Rodriguez.

#### 3.5 Con Edison Operating Procedures and Reserves [G1: R7]

NYISO certified Con Edison in full compliance. The NYISO submitted Con Edison Procedures S00326N and S005-02-19. RCMS found the NYISO in full compliance with requirement G1: R7 for 2018. Motion by Mr. Spagnolo and seconded by Mr. Shanahan.

**Action Item 223-1** RCMS requested Mr. Grant to provide Con Edison procedure paper documents that were referenced in G1:R7 at the next RCMS meeting for in person review but no electronic copies will be provided.

#### **4.0 CERTIFICATION OF NYISO LCR ECONOMIC OPTIMIZATION METHODOLOGY REQUIREMENTS [A.2: R1.1 – R1.4]**

Since the last RCMS meeting there have been discussion with Mr. Adamson, Mr. Gioia, Ms. Wilczek, and the NYISO. From the FERC filing for a tariff change concerning the LCR methodology, the NYISO has responded to the deficiency letter. Included in that letter was a mention of the 1045 method with respect to LCR methodology that there was no intent to challenge the 1045 method for IRM but has remained in support of alternative method for the LCR. Not clear if any other parties to the deficiency letter have responded. Discussion will continue at the EC. Unless FERC approves the LCR by Oct 9, the NYISO will still need to utilize the old method for 2019.
