2.1 RCMS Draft Minutes #223

The meeting minutes for RCMS meeting #223 were reviewed and approved with modifications received from Con Edison.

2.2 RCMS #223 Status Report

RCMS status report was submitted.

2.3 RCMS Action Items List

No items listed. In the room, the RCMS reviewed the Con Edison procedures that were mentioned during the last meeting. The procedures were dated in 2014 so RCMS have previously seen these versions. ~~Day-Day~~-ahead unit commitment procedure was not changed. Review of the Con Edison procedure has been completed by RCMS and returned to the NYISO.

3.0 NYSRC 2018 Reliability Compliance Monitoring Program

3.1 2018 Compliance Monitoring Program Update

Mr. Adamson reports updates to the spreadsheet from last month's RCMS compliance reviews to show G1 from R1 to R7 and all assessments in full compliance with the rules and operating report. Footnote 6 was added to note the Con Edison procedure review.

3.2 August 2018 Operating Report

NYISO submitted to RCMS the August Operations Report certifying full compliance with C.8 (R1) for August 2018. RCMS found the NYISO in full compliance with requirement C.8 (R1) for August 2018. Motion by Mr. Head and seconded by Mr. Shanahan.

3.3 GO Procedures for Testing Dual Fuel Capability of MOB Combined Cycle Units [G.2: R5]

NYISO stated they are in full compliance. NYISO submitted that each unit with this capability was tested. Statement was submitted that Astoria Energy provided evidence of test procedures for fuel swap testing during the 2017-2018 capability period in a transmittal to the NYISO on 4/30/2018, and that NYPA 500 provided evidence of test procedures for fuel swap testing during the 2017-2018 capability period in a transmittal to the NYISO on 9/24/2018. ~~Astoria energy provided evidence of test procedures for NYPA 500.~~ RCMS found the NYISO in full compliance with requirement G2:R5 for 2018. Motion by Mr. Clayton and seconded by Mr. Head.

3.4 GO Dual Fuel Capability Testing of Combined Cycle Units [G.2: R6]

NYISO stated they are in full compliance. NYISO sites the test data reports for ~~Astoria as before~~ the generation facilities listed under item 3.3 above. RCMS found the NYISO in full compliance with requirement G.2: R6 for 2018. Motion by Mr. Pandit and seconded by Mr. Spagnolo.

3.5 MP Transmission Data Reporting [I.4: R3]

NYISO provided that all equipment owners are in full compliance. The NYISO submitted evidence of reviewed short circuit databases and referenced the NYISO Reliability Analysis Data (RAD) Manual. All data verifications have had MP responses. RCMS found the NYISO in full compliance with requirement I.4:R3 for 2018. Motion by Mr. Shanahan and seconded by Mr. Clayton.

3.6 Compliance Reviews Scheduled for Next Meeting: The requirements that will be addressed will be in accordance with the schedule: G.4: R1 and G.4: R2

4.0 CERTIFICATION OF NYISO LCR ECONOMIC OPTIMIZATION METHODOLOGY REQUIREMENTS [A.2: R1.1 – R1.4]
