### **3.0 NYSRC 2019 Reliability Compliance Monitoring Program**

#### 3.1 2019 Compliance Monitoring Program Update

The 2019 Reliability Compliance Monitoring Program, updated to include compliance reviews at the last meeting, was presented to the RCMS. Requirements C.6, C.7 and C.8 were found to be in full compliance. There were no questions or comments from the group.

#### 3.2 April and May 2019 Operating Reports [C.8: R1]

NYISO submitted the April 2019 Operations Report to RCMS certifying full compliance with [C.8: R1]. RCMS found the NYISO in full compliance with requirement [C.8: R1] for April 2019. A motion to find the NYISO in full compliance was made by Mr. Ridolfino and seconded by Mr. Clayton. The motion was approved. May 2019 Operations report was not available yet.

#### 3.3 2019-21 NYCA Resource Adequacy Review [A.3: R1]

Mr. Jiang from NYISO presented the NYCA Resource Adequacy Assessment report to the NYSRC for the years 2019-2021. Mr. Adamson suggested removing “Draft...” from the top of the report. Mr. Jiang affirmed that after the report is approved following the discussion “Draft...” will be removed prior to publishing it. Mr. Adamson raised a concern that as DER gains relevance in the future, calculations for LCR and IRM requirements should consider them during the studies. After the discussion RCMS found the NYISO in full compliance with requirement [A.3: R1] for 2019. A motion was made by Mr. Head and seconded by Mr. Clayton. The motion was approved.

There was an action item added for NYISO: Mr. Grant to provide NYSRC updates on proposal to long term IRM studies.

#### 3.4 GO Generation Net Dependable Capacity Tests [I1: R3]

NYISO submitted documentation, including relevant sections of the NYISO Installed Capacity Manual, to RCMS certifying full compliance with [I.1: R3]. RCMS found the NYISO in full compliance with requirement [I.1: R3] for 2019. A motion was made by Mr. Spagnolo and seconded by Mr. Shanahan to find the NYISO in full compliance. The motion was approved.

3.5 GO Generation Reactive Power Capacity Tests [I1: R4]

NYISO submitted documentation, including relevant sections of the NYISO Ancillary Services Manual, to RCMS certifying full compliance with [I1: R4] for 2019. RCMS found the NYISO in full compliance with requirement [I1: R4] for 2019. A motion was made by Mr. Ridolfino and seconded by Mr. Spagnolo to find the NYISO in full compliance. The motion was approved.

3.7 Review of 2018 Intermediate ATR

The report has gone through NPCC review which approved it as final 2018 NYISO ATR report including the errata changes. RCMS found the NYISO in full compliance for the 2018 Intermediate ATR report. A motion was made by Mr. Shanahan and seconded by Mr. Pandit. The motion was approved.
