Action Item 234-1: Mr. Spagnolo to work with Mr. Adamson to determine how to reference the list of ARR at the NYSRC website. Mr. Adamson found one document referencing potential CEII material from PSEG Long Island. He will reach out to Zoraini Rodriguez for clarification. Due date moved to next meeting, 12/03/19.

Action Item 236-1: NYISO to investigate the posting of CEII material necessary for compliance review behind the NYISO website firewall. Mr. Grant mention that NYISO does Webex meetings where CEII material can be displayed. He suggested that RCMS members sign into the webinar where they would be able to see the CEII materials. There was a concern raised regarding sending out webex invite since it can be forwarded to others and then anybody can access it. This solution is currently debated. Due date moved to next meeting 12/03/19.

## 3.0 NYSRC 2019 Reliability Compliance Monitoring Program

### 3.1 2019 Compliance Monitoring Program Update

The 2019 Reliability Compliance Monitoring Program, updated to include compliance reviews at the last meeting, was presented to the RCMS. Requirements I.2: R2, I.2: R3 and I.4: R3 were found to be in full compliance. There were no questions or comments from the group.

Mr. Clayton proposed to RCMS members to allow for collective approval of agenda items: 3.2, 3.4 and 3.5. To be noted: RCMS members have reviewed all the items up for compliance actions carefully and have agreed that they can all be voted for as a single consent agenda. A motion to find the NYISO in full compliance for items 3.2, 3.4 and 3.5 for 2019 was made by Mr. Clayton. Mr. Paszek approved the motion and Mr. Clayton seconded it.

### 3.2 September 2019 Operating Reports [C.8: R1]

The NYISO submitted September 2019 Operations Report to RCMS certifying full compliance with [C.8: R1]. RCMS found the NYISO in full compliance with requirement [C.8: R1] for September 2019. The motion was approved as stated in item 3.1 above.

### 3.3 2019 NYCA Transmission Review [B.2: R1]

The NYISO submitted documentation and Mr. Burrell presented the 2019 Interim Area Transmission Review (ATR) presentation. Mr. Clayton proposed the motion to find the NYISO in full compliance for [B.2: R1]. There is a caveat that any changes

imposed by NPCC will be further reviewed by NYSRC. Mr. Ridolfino approved the motion and Mr. Shanahan seconded it.

3.4 GO Duel Fuel Capability Testing of Combined Cycle Units [G.2: R6]

The NYISO certified full compliance with [G.2: R6]. The motion was approved as stated in item 3.1 above.

3.5 Con Ed Identification of Eligible Black Start Units [G.4: R2]

The NYISO certified full compliance with [G.4: R2]. The motion was approved as stated in item 3.1 above.
