# 3.0 NYSRC 2021 Reliability Compliance Monitoring Program

3.1 2021 Compliance Program Update

Mr. Adamson briefly went over the Compliance Program report with no comments from RCMS members.

3.2 January Operating Report [C.8: R1]

The NYISO submitted its January 2021 Operations Report to RCMS certifying full compliance with [C.8: R1]. A motion was made by Mr. Shanahan, and seconded by Mr. Clayton, to find the NYISO in Full Compliance with this requirement for January. following which the RCMS found the NYISO to be in full compliance with requirement [C.8: R1] for January 2021.

3.3 Transmission Planning Criteria [B.1: R1 to R4] – M. Capano

The RCMS reviewed the NYISO submittal of its certification as per the 2021 Reliability Compliance Monitoring Schedule. A motion was made by Mr. Shanahan, and seconded by Mr. Paszek, to find the NYISO in Full Compliance with this requirement, following which the RCMS found the NYISO to be in full compliance with requirement [B.1: R1 to R4] for January 2021.

3.4 2020 NYCA Transmission Review [B.2: R1] – M. Capano

Mr. Burrell presented a summary of the 2020 ATR. Following general comments and questions, a motion was made by Mr. Shanahan, and seconded by Mr. Clayton, to approve the Transmission review subject to a follow up meeting between Mr. Adamson and Mr. Clayton with the NYISO on the CEII information in the appendices. The motion was carried and the RCMS found the NYISO to be in full compliance with requirement [B.2: R1].

3.5 List of NYS BPS Facilities [B.3: R1, R2] – M. Capano

Certification of the NYISO maintaining a BPS list was reviewed. A motion was made by Mr. Mullin and seconded by Mr. Ridolfino to approve the certification subject to a follow-up verification of the actual BPS list, which is CEII information and not distributed. This will be performed by Mr. Adamson and Mr. Clayton. The motion was carried and the RCMS found the NYISO to be in full compliance with requirement [B.3: R1, R2].
