3.0 NYSRC 2021 Reliability Compliance Monitoring Program

3.1 2021 Compliance Program Update

Mr. Clayton highlighted the topics that were scheduled to be reviewed at today's meeting with no comments from RCMS members.

3.2 September 2021 Operating Report [C.8: R1]

The NYISO submitted its September 2021 Operations Report to RCMS certifying full compliance with [C.8: R1]. The October report was sent out to RCMS members after meeting materials were posted and will be reviewed at the next RCMS meeting.

A motion to find the NYISO in Full Compliance with this requirement [C.8: R1] for September 2021, was made by Mr. Spagnolo, and seconded by Mr. Gordon, following which the RCMS found the NYISO to be in full compliance.

3.3 GO dual fuel capability testing of combined cycle units [G.2: R6]; – • – M. Capano

The RCMS reviewed compliance documentation for this requirement, which included the dates of performance of required testing that was performed during the compliance period. A motion to find the NYISO in Full Compliance with this requirement [G.2: R6] for 2021 was made by Mr. Head, and seconded by Mr. Spagnolo, following which the RCMS found the NYISO to be in full compliance with no further discussion and no one opposed or abstaining.

3.4 Generation outage statistics report [I.2: R3] – • – M. Capano

The RCMS reviewed compliance documentation for these requirements. The 2020 data has been provided to ICS and the EC as part of the assumptions matrix which was approved at the August and October EC meetings. A motion to find the NYISO in Full Compliance with this requirement [I.2: R3] for 2021 was made by Mr. Shanahan and seconded by Mr. Clayton, following which the RCMS found the NYISO to be in full compliance with no further discussion and no one opposed or abstaining.

3.5 SCR performance report [I.2: R4.4]– M. Capano

The RCMS reviewed compliance documentation for these requirements, which included: several sections of the Market Services Tariff (MST) and ICAP manuals.

A motion to find the NYISO in Full Compliance with this requirement [I.2: R4.4] for 2021 was made by Mr. Shanahan, and seconded by Mr. Spagnolo, with the caveat that the NYISO will revise the Compliance submittal to provide additional detail as to testing/letter dates and noting the forward compliance period being certified to (2021), via email to the RCMS. With the inclusion of the caveat, the RCMS found the NYISO to be in full compliance with [I.2: R4.4]
