During the presentation, Mr. Carlson noted that the NYISO has changed its study methodology to optimize economic outputs. The model had previously tended to apply downstate Locational Requirement (LCR) based solutions to statewide problems.

Dan Head made the motion to find the NYISO in full compliance. Rahul Pandit seconded. RCMS found NYISO in full compliance with requirement **A.2: R1**.
