- Mr. Clayton will step down as Chair as of July 31. Mayer Sasson to take over as chair, Chris Wentlent to take over as Vice-Chair on August 1.
- Matt Koenig has taken over reporting on DER activities. RRS should focus on DER.
- Chris Wentlent reported on the NYS DEC meeting. Mr. Clayton will provide the report to RRS.
- The NYISO will provide LOLH and EUE metrics for comparison to the 0.1 LOLE criteria to the Resource Adequacy Working Group.
- The EC discussed the PSC proceeding on resource adequacy and transmission planning. Meetings are coming up shortly. NYSRC will monitor and report.

7.2. NYSRC ICS Meeting Report – A. Adamson

Mr. Adamson provided a summary review of last Tuesday’s ICS meeting topics.

- ICS performed a parametric review of last year’s IRM study which will be reported at the next EC meeting. The IRM will continue to increase as a result of load forecast uncertainty, among other factors. A working group will look at load forecast uncertainty.
