3.4. Discussion items

3.4.1 NYCA Long-Term Reliability Risk Priorities – R. Clayton

RRS continued its review and agreed to share draft with EC for their commentary. It was noted that certain high reliability risks cited in the risk priorities draft could be examined by implementing a future action in the High Intermittent Renewable Resource White Paper: “Examination of NYCA system risks that could occur under extreme but realistic contingencies associated with wind and solar resources because of the high level of uncertainty of weather and other factors that could impact their availability.”

3.4.2 Revision to ConEdison’s Thunderstorm Watch Operating Procedure– M. Paszek

Mr. Paszek presented a revision to the existing procedure based upon the past 10 years of experience. The historical record supports an increase in the threshold for declaring a Thunderstorm Alert with minimum impact on reliability. The primary factor that permits this revised procedure is that the Con Edison system has deployed enhanced controls, including reclosure technology, since the previous procedure was initiated. The advantages of the revised procedure include reduced substation staffing requirements and reduced economic uplift. The proposed revised procedure has been approved by NYISO SOAS & OC, and supported by NYISO. The proposed thunderstorm procedure also meets NYSRC Reliability Rule G.1, New

York City System Operations. Mr. Paszek will confirm that Con Edison has implemented the revised procedure as an operating procedure. (Action Item 252-1)
