- The EC recommended to add DER to the NYCA risk assessment. RRS determined there is not a need at this time as NERC and NPCC are developing standards to address DER.
- The NYSRC Reliability Rules manual has been updated and posted to the website.
- NYISO recorded the 2020 peak load of 30676 MW at a temperature of 95 degrees. NYISO estimates a 2% statewide load reduction due to Covid.
