1. Introduction

Chair Wilczek called the NYSRC Installed Capacity Subcommittee meeting to order at 10:00 a.m. on May 2, 2018.

2. Approval of Minutes for Meeting #206

The meeting minutes were approved.

3. Review Action Item List

ICS reviewed the Action Item list, no changes were made.

4. Review of ICS Tasks

4.1. NYSRC Website Re-Organization

John Adams stated that they have started the NYSRC website re-organization process which should be completed by the next ICS meeting for review.

4.2. ISO-NE ICAP Export Update

Nate Gilbraith provided an update on capacity exports to ISO-NE. Nate stated that there was a 0 MW reduction over the NY AC ties however MW's were exchanged between resources in the

monthly bilateral period. Josh Boles stated that the NYISO will update market participants later in the day if there will be a sale from a locality for NYISO's June 2018 auction. Mark Younger asked for clarification on what the exact process will be each month to notify participants if a sale will occur or not. Josh Boles stated that because this is a new market mechanism NYISO will notify participants and update the ICAP AMS.

4.3. Policy 5 Revision

Greg Drake provided clarifying language to section 3.5.7 for External Control Area Capacity. The section describes the process of reserving tie capability for grandfathered contracts and the NYISO's study to evaluate additional capacity import capability over the ties without degrading the NYCA LOLE. Al Adamson also indicated that if the EC has an approved version of the Installed Reserve Margin voting rules he will include them in the revisions.

4.4. Assumptions Matrix

ICS continued reviewing the assumptions matrix for the 2019 IRM study. Chris Lentlet asked if the Governor's new energy efficiency target (3%) will be used in the load forecast. Mark Younger responded that the order is not finalized and would be included in the NYISO's forecast going forward once finalized. Greg Drake stated that there are no changes to the topology this year and that we should have a presentation on SCR's in June. It was requested that the EFORD charts be changed to align with the NYISO capacity zones. Mark Younger requested that a sensitivity be performed again this year limiting the import capability into southeastern NY.
