Mr. Yeomans expressed the intention of fatigue factor was to account for a decrease in response in the event there were multiple or excessive activations of Demand Response. Clarification was also offered for ACL= Average Coincident Load; CBL= Customer Base Load. A motion to find the NYISO in full compliance for 1.2:R4.1-4.3 was made by Mr. Shanahan and seconded by Mr. Head. The motion passed, RCMS found the NYISO in full compliance with 1.2:R4.1-4.3.*
