Mr. Clayton called the RCMS Meeting #282 to order at 10:59

- 1. Introduction
 - 1.1 Executive Session None
 - 1.2 Requests for Additional Agenda Items None requested.
- 2. Approval of Minutes/Action Items
 - 2.1 RCMS Draft Minutes #281 Mr. Clayton presented the draft minutes page by page. All RRS and RCMS roster updates have been submitted and are being developed for the website. No comments by RCMS and it is approved as final.
 - 2.2 RCMS #281 Status Report Mr. Clayton presented. No questions or comments.
 - 2.3 RCMS Action Items List No discussion.
- 3. NYSRC 2024 Reliability Compliance Monitoring Program
 - 3.1 2024 Reliability Compliance Program Mr. Yeomans mentioned the three requirements for this month including the agenda and that there are four requirements scheduled for the April RCMS meeting.

3.2 Transmission Planning Criteria [B.1: R1-R4]

Mr. Clayton stated this requirement is for all planning performance studies for R1 through R4. Attachment 2023 ATR was approved in November by RCMS and this document has been submitted for evidence in this compliance review. Mr. Clayton mentioned that in subsequent meetings, there will be a need to review if the ATR alone is to fully show compliance after a more comprehensive interpretation is made of B.1: R1-4. There may also be a need to link B2 to B1 in the reliability rules, so this will need further consideration going forward. It is not thought there is any change required by the NYISO only a more complete wording to eliminate the minor confusion. To accept the report for NYISO compliance, Mr. Ridolfino made a motion, Mr. Clayton seconded, the motion passed, none opposed, no abstentions. RCMS found the NYISO in full compliance with B.1: R1-R4 for 2024.

3.3 List of NYS Bulk Power System facilities [B.3: R1-R2]

Mr. Clayton stated that NYISO evidence was for Gold Book and A-10 classification with some information removed because of CEII information. To accept the report for NYISO compliance, Mr. Pandit made a motion, Mr. Ridolfino seconded, the motion passed, none opposed, no abstentions. RCMS found the NYISO in full compliance with B.3: R1-R2 for 2024.

- 3.4 January 2024 Operating Reports [C.8: R1] Mr. Yeomans reviewed NYISO Operations Report by noting the loads given the overall milder winter, a few TSA noted in January, and no Major Emergencies. To accept the report for NYISO compliance, Mr. Pandit made a motion, Mr. Gordon seconded, the motion passed, none opposed, no abstentions. RCMS found the NYISO in full compliance with C.8:R1
