1&2 Roll Call and Request for Additional Agenda Items – H. Kosel / B. Shanahan

- No additional Agenda items identified.

3. Approval of Minutes for Meeting #286

- Meeting minutes for previous meeting #285 was approved with minor editorial changes.

4. Review of Action Item List – H. Kosel

- List is unchanged from previous meeting.

5. Chair update on recent EC actions

- EC Discussed ICS modeling of OSW correlated outages to include neighboring areas.

6. Preliminary Assumptions Matrix Review – B. Prinsloo

- Reviewed the Matrix for the upcoming study year,

7. Final Capacity Accreditation Factors - Otito Onwuzurike

- Brief presentation on how accreditation factors are determined and the final CAF's for 2024/25. This has been presented elsewhere (ICAP etc).

8. DER Research – B. Prinsloo

NYISO presented initial research on DERs operational characteristics, the definition of a DER, and aggregations. Various options for aggregation were presented. Further development of this topic will be completed by Summer 2024. A DER may be one of the following categories of facilities electrically located in NYCA:

- A facility comprising two or more different technology types located behind a single point of interconnection with a maximum Injection Limit of 20 MW
- A Demand Side Resource
- A generator with a maximum Injection Limit of 20 MW

9. Gas Constraints White paper – L. Carr

NYISO presented an updated proposal to model gas constraints in the 2025 PBC. The fuel constraints will be modeled for the first time during the IRM study for the 2025- 2026 Capability Year. ICS will be seeking EC approval to move forward with the PBC assumption presented, while ICS finalizes the whitepaper.

- Based on analysis of historical gas production and weekly fuel surveys, the NYISO developed the following initial recommendation of fuel constraints to model in the Preliminary Base Case (PBC) of the 2025-2026 IRM study
- For the PBC, the study will include the initial recommended modeling of fuel constraints applied to gas-only and dual fuel generators in Load Zones F-K.
- Mr. Younger pointed out that the presentation and white paper say that in the FBC the available oil modeled must be reviewed to reflect actual fuel elections. Firm fuel levels selected by generators must be modeled in the FBC as they are available after August 1st, not just reviewed. Several issues would exist if that is not done, including overvaluing CAFs for non-firm generators, incentivizing units to be non-firm from an economic standpoint and over-modeling Firm Units in the FBC.
- D. Zhang pointed out that the NYISO is attempting to incentivize Firm commitments and will take this issue back for additional consideration and recommendation, potential update of Whitepaper.
- It was agreed that the new gas constraints would be presented to the EC in the Assumptions Matrix this month but that the Whitepaper approval will be deferred pending resolution of how firm and non-firm generators are treated.

10. IRM Load Shape Comparison – M. Lucas

NYISO provided a comparison between the high load hours of actual load shapes, and the high load hours of modeled load shapes that are used in the IRM study last year, with the 2013, 2017 & 2018 years that are currently used for various load bins. New load shapes will represent less energy in the system and should result in a decrease in IRM. Magnitude of change is TBD. Modeling of BTM solar as generation pending a comprehensive load modeling improvement which is a priority for 2025. Sensitivity cases will be produced this Summer prior to any implementation of changes into the 2025-26 IRM study.

11. Parametric Results – B. Prinsloo

- Initial parametric results were presented although most data is not yet available (Load forecast and Gold Boo data).

12. Tan45 Methodology Review – L. Carr, M. Lucas

- Initial Asset Allocations and Options for review of the Tan45 methodology were presented. It was agreed that Option 1 (Utilize the same allocation used in the High Renewable Phase 3 whitepaper) should be selected so that sensitivity work can move forward for some results by the next ICS meeting. A sensitivity will likely be added to look at extreme weather impacts on OSW (including NE) depending upon data review.
- Suggestion were made by Mr. Younger to prioritize sensitivity work, such as start on CHPE and OSW first. Mr. Zhang and Mr. Kosel agreed.
