2.3 RRS 296 Action Item List - W. Yeomans

- Action Item 284-5 – W. Yeomans reported that he met with R. Gonzales and discussed the NYISO Transmission Security Margins methods and assumptions. There is a group assigned by the Executive Committee to track this issue, led by C. Dahl, which is currently monitoring any implications for setting this year's IRM and the Transmission Security Limit Floor for the LCR Optimizer.

- No update. Future action depends on NYISO study to be completed in late 2025. Roger Clayton asked if the NYISO had procured a consultant resource for the 2025 study. The NYISO responded that it had not yet procured a consultant.
