Mr. Yeomans called the RCMS Meeting #295 to order at 12:15 pm

- 2. Approval of Minutes/Action Items

- 3. NYSRC 2025 Reliability Compliance Monitoring Program

3.1 2025 Reliability Compliance Program – Mr. Yeomans presented the 2025 document to RCMS members. The tracker was up to date for all the previously completed items.

### 3.2 2025 Locational Capacity Requirements [A.2: R1]

NYISO submitted the self-certification document and a report in support of this agenda item. Mr. Zhang summarized the report for RCMS members. As per the report NYISO has calculated that all the zones in NYCA will meet the Locational Capacity Requirements for the capability year 2025 – 2026.

3.3 Resource Adequacy Assessment for the Capability Year 2025-2026 [A.3: R1]

NYISO submitted the self-certification document and a report in support of this agenda item. Mr. Zhang summarized the report for RCMS members. According to the data mentioned in the report New York Control Area will meet the resource adequacy requirements and the LCR requirements for the capability year 2025-2026. Mr. Yeomans made a comment about the impact of Wind resources in the calculation of margin cautioning that wind's output could be dropped significantly in real time conditions.

Mr. Head made the motion that RCMS found the NYISO in full compliance for rules [A.2: R1], [A.3: R1], [G.1: R1-R4, R7], [G.2: R1], [G.2: R2] and April Operations Monthly Report [C.8: R1].

Mr. Gordon seconded the motion, none opposed and no abstentions. RCMS found the NYISO in full compliance for all the above mentioned rules.
