4.0 Large Load Discussion □ - W. Yeomans Status Report - W. Yeomans

- Discussed status of potential SAR related to the SPIDR WC for PRC-6-5, primary objective was to address BTM solar consideration in Transmission Owner UFLS programs. NYSRC EC provided comments in 2024 however SAR has not moved forward in the NERC process.
- Reviewed history of NYSRC commentary on large loads, including a Working Paper to Facilitate RRS discussion of large load impacts to Bulk Power System Reliability. This included a presentation of previous NERC reviews of system incidents that affected large loads (Virginia incident).
