1. Regular Agenda Items:

- 1.1. **Introduction** – M. Domino called the NYSRC Executive Committee Meeting No. 315 to order at 9:30 a.m. on July 18, 2025. A quorum of 12 Members and Alternate Members of the NYSRC EC was established with one proxy.
- 1.2. **Identification of Visitors** – Visitors in attendance were identified via the participant list.
- 1.3. **Request for open session agenda items** – None were requested.
- 1.4. **Report on Meeting #313 Closed Session** – M. Domino stated that the NYSRC EC discussed personnel, PRC-006, 2026 NYSRC 2026 compensation, proposed 2026 budget, and continued discussion on a nominations policy.
- 1.5. **Request for closed session agenda items** – None were requested.
- 1.6. **Declarations of Potential “Conflicts of Interest”** – There were no new declared conflicts of interest.

2. Meeting Minutes/Action Items List – H. Schrayshuen – EC Secretary

- 2.1. **Approval of Minutes for Meeting #314 (June 13, 2025) Attachment #2.1** – H. Schrayshuen presented attachment #2.1 which included all comments received as of July 12, 2025. There were two changes proposed. S. Whitley made a motion to approve the minutes as modified. The motion was seconded by R. Bolbrock and approved by the EC members in attendance (13 - 0). 3. Organizational Issues

3.1. Treasurer’s Report – C. Tackman – Treasury Services

- 3.1.1. **Summary of Receipts & Disbursements - Cash Receipts and Disbursements – Attachment #3.1.1** – C. Tackman presented attachment #3.1.1 - Statement of Cash Receipts and Disbursements for June 2025, noting the end-of-month cash balance is \$434,723.58, which includes \$130,000 of Call for Funds Pre-payments. C. Tackman stated the Q3 Call for Funds are complete.
- 3.1.2. **NYSRC 2026 Funding Mechanism – Attachment #3.1.2 – EC Approval** – C. Tackman presented attachment #3.1.2 stated confirming the NYSRC 2026 Budget funding. M. Clayton stated that NERC issued a level 3 alert on Inverter-Based Resource Performance and Modeling and will have a webinar on the topic on August 4, 2025.

Dellatto stated that the EWWG had presentations on Extreme Weather Resource Adequacy Modeling, the New York Renewable Power Profile Dashboard and wind lulls. J. Dellatto stated that Hilme Athar will be taking the role as Chair for the EWWG. R. Clayton and C. Dahl thanked J. Dellatto for his leadership.

7.1. NYISO Comprehensive System Planning Process – Z. G. Smith -

7.1.1. NYISO System & Resource Planning Status Report – Attachment #7.1.1 – Z. G. Smith stated that the PSC has cancelled the Public Policy Transmission ~~need~~ Need in New York City. Z. G. Smith stated that he will discuss the next steps when they are determined.

7.2. NYISO Markets Report – S. Johnson - Attachment #7.2 – S. Johnson stated that ~~that~~ the FERC has accepted the NYISO Balancing Intermittency policy. S. Johnson stated the NYISO is continuing to have conversations on seasonal capacity markets and winter assumptions with Stakeholders. S. Johnson will provide a future presentation on the stakeholder discussions related to Market Changes. (AI-315-~~24~~)

7.3.2. NYISO Operations Report (long form) – June 2025 – Attachment #7.3.2 - A. Markham presented attachment #7.3.2. stating that, the peak load for the month was 31,857 MW, which occurred on June 24, 2025. There were 14.3 thunderstorm

alert hours and 0 hours of NERC TLR level 3 curtailments in June.

7.3.3. Presentation on June 24 Major Emergency – A. Markham presented attachment #7.3.3 on the major emergency that occurred on June 24, 2025.

8. Decarbonization & DER Report – M. Koenig, Con Edison - M. Koenig - Attachment #8.1 – M. Koenig presented attachment #8.1 which included three New York Times articles titled, The Work is Warming up. And its's Happening Faster and There's a Race to Power the Future, China is Pulling Way, and At Amazon's Biggest Data Center, Everything is Supersized for A.I., details on the Governor's directive for New York Power Authority to develop and construct a zero-emission advance nuclear power plant in Upstate New York, [Utility Dive: FERC's Christie calls for dispatchable resources after grid operators come 'close to the edge'](#). The report also includes a snapshot of the most recent NYISO Interconnection Queue.

9. Environmental Status Report/Issues – C. Wentlent – C. Wentlent stated that the NYSRC, DEC, and NYSEDA met on July 15, 2025. C. Wentlent stated that the RGGI program announced the third program review is complete with changes to be in effect from 2027-2037. New York will have its own stakeholder process. There will be a State Energy Plan on July 23, 2025. If the plan is approved there will be a stakeholder process to submit comments on the plan and informational meetings. The next NYSRC/DEC meeting is on September 11, 2025.

10. State/NPCC/Federal Energy Commission Activities

10.1. NPCC Report – M. Sasson – M. Sasson stated the NPCC Board of Directors met on June 5, 2025. There was an educational session which focused on Large Loads. The NPCC Board approved the [NPCC 2026 Business Plan and Budget for NERC's consideration at the August 14, 2025 NERC Board of Trustees meeting](#). P. Fedora stated that there was presentation on the [NPCC 2025 Summer Reliability Assessment](#). P. Fedora stated that the NPCC Board appointed two new members.

10.2. NERC/FERC Report – P. Fedora stated that the FERC posted the agenda for their [Open Meeting](#) on July 24, 2025. The White House appointed David LaCerte to serve the remainder of [Commissioner Willie Phillips](#) term. The nomination ~~still~~ needs to be confirmed by Congress. P. Fedora stated that the NERC issued a draft of the [2025 ERO Reliability Risk Priorities Report on July 7, 2025. The comment period closes July 18, 2025.](#) The NERC Member Representatives Committee [held an information Session on](#) ~~met on~~ July 17, 2025. The NERC Modernization of Standard [Processes and Procedures Task Force \(MSPPTF\)](#), will hold a webinar on July 21, 2025 on a white paper focusing on [NERC Standards Development](#). Comments on the white paper will be open [through](#) ~~until~~ August 27, 2025. The NARUC [2025 Summer Policy Summit](#) will be held July 27-30, [2025 in Boston MA](#).
