2. Approval of Minutes for Meeting #270, #271 – B. Shanahan

3. Review of Action Items List – B. Shanahan

- 257-1 – NYISO is going to develop a scope for a Phase 4 High Renewables White Paper that includes anticipated project/technology changes and fuel mix by March 2023.
- M. Younger – it seems that there is unclear assumption. B. Shanahan and M. Mager also agree that study should be done every three year. Identify the number of important issues instead of doing this study.
- M. Younger – Should have clear direction of change system before working on this scope.
- B. Shanahan - Scope for Phase 4 late 2024. Going to make in the action item.
- B. Shanahan – will update the Action Items List with M. Younger's suggestion.
- B. Shanahan – Update the Model Improvement Work.
- Leave the Enhance Maintenance Scheduling in MARS as ongoing.
- B. Shanahan - Gave suggestion on load forecast uncertainty white paper.
- M. Younger – Wait to see what NYISO comes up with the white paper on load shapes.
- M. Shuler - Wants to confirm that variable scaling LFU multipliers and the shapes as primary topic of LFU phase 3 analysis. Present that in March 2023.

6.4. Y49 Sensitivity Tan45 Results – R. Carlson

- R. Carlson - Sensitivity was requested and reported as a parametric run where the transition rate utilized for Y49 was determined during the 2015 -2019 period
- M. Younger – Should we revise anything with this information. Very concern if we introduce subjective process. Reality is that we get rate of outage problem and that is risk to the system. If we don't address unit or line outage there will be repercussion.
- K Zannat – Suggestion is to make a decision at EC level instead of ICS.
- B. Shanahan – Should we come up with a recommendation from ICS to EC.
- M. Younger – Recommends that if people want to pursue the idea of changing policy 5 then it should trigger intensive study that represents outage risks.
- B. Shanahan – Agrees It should be communicated to the EC.
- J. Boles – Needs NYISO feedback. For the large outage the risk is real. Who should bare the brunt of this risk? Should this risk be spread around the system? It will be lot out of figuring out what outages to include and to devise the approach of spreading around system.
- B. Shanahan – Looking for EC direction on this.

7. 2023 White Paper / Study Prioritization Topic Discussion - B. Shanahan / Y. Huang

- Y. Huang – Strategic plan for 2023 identified modelling major white paper.
 - (i) Gas constraint white paper – This will take year to complete. Feb meeting to get ICS agree on the path. Goal to have final recommendation by Dec 2023. NYISO will interim reporting between Feb to Dec monthly basis.
 - (ii) EOP review focusing on emergency assistance and SCR's. NYISO will bring back scope in Jan meeting. NYISO will be reaching final recommendation by August 2023.
 - (iii) Phase 3 LFU white paper.

- B. Shanahan – Does ICS agrees on scope presentation.
- B. Shanahan – Is going to present this white paper scopes to the EC pending approval.
- M. Younger – Recommends calling it as preliminary scope presentation to ICS in Feb 2023.
