A new Large Load Working Group is going to be created to address changes needed for new large loads in the state. RRS is soliciting members and SME's.

5.0 Resource Adequacy Reliability Rules

5.1. September NYSRC Executive Committee Discussion to clarify A2 R1.3 - Wes Yeomans

5.2. Draft Resource Adequacy Reliability Rules - W. Yeomans & Yvonne Huang

- Discussion started with W. Yeomans and Y. Huang concerning ambiguous wording and subsequent compliance verification for RR A2.R1.3, related to use of modeling to determine LCR's and IRM.
- Uncertainty regarding LCR floors to be applied to LCRs given uncertainty in the actual in-service date of the CHPPE project.
- As a result of previous discussions and reviewing the overall issues above, NYISO presented several proposed rule changes to A2 Reliability Rule to address improvements to how the market accounts for and assigns deficiency charges to LSE's.

- A new PRR-156 (projected) will be submitted at a future RRS meeting (November target), to begin the rule review process.
