Status Report - RRS Meeting #309 – Thursday, April 30, 2026

- **Reviewed RRS 307 Status Report to EC**
- **Review RRS Actions Items and Goals**
 - Added action items for PRR 158 and review of NPCC Directory 1 recent changes, PRR 159 and 160 (Emergency Operating Capability change), and PRR 161 RR C.7 Exceptions
- **Review and Approve Draft Minutes from RRS Meeting 308 (April 2)**
- **PRRs “Under Development”**
 - PRR 158 – Resolve Difference between NYSRC Reliability Rule Table B-1 and NPCC Directory 1, Table 1, and NERC Standard TPL-001-5.1, Table 1 regarding Multiple Tower Exclusion Criteria (*Now Under Development and seeking feedback from Executive Committee.*)
 - PRR 159 and PRR 160 Modification to the underground cable operating criteria found in Table C-2 and Table B-2, respectively
 - RRS approved motion to recommend EC post PRRs for comment asap and that the comment period close in an abbreviated fashion so that comments can be fully considered during RRS Meeting # 310 (June 4, 2026). This would allow EC to take action on PRR 159 and PRR 160 at its June 12, 2026 meeting in a timely fashion for the Summer operating season.
 - PRR 153 - TS Planning Performance Requirements - Include "Sudden loss of fuel delivery system to multiple solar & wind plants" as Category I & II Design Contingencies in Table B-1. (*Continued development of PRR 153 may be suspended pending activities at EWWG and input from NYISO.*)
 - Joint EWWG/RRS meeting tentatively being planned for July 9, 2026. NYISO requested that EWWG make a formal request to NYISO’s Zach Smith, Keith Burrell, and Aaron Markham that outlining scope of NYISO deliverables sought by EWWG
 - PRR 155 – Verification of AS-Built IBR Plant Conformance (*Still pending within the IBR WG and as reported last month this rule will likely develop as a proposed revision to RR B.5 later this year.*)
 - PRR 157 – Create Statewide Implementation Plan regarding participation of Large Load interconnections in Under Frequency Load Shedding programs (*Awaiting draft PRR request to be completed and submitted to RRS. This is expected to be available for RRS Meeting 310 (June 4).*)
 - PRR 161 – Proposed Updates to RR C.7 to reflect expiration dates are required for new Exceptions

- **Other RRS Matters**
 - Reminded RRS that the requested review and responses to the draft worksheet is due by May 22, 2026 to allow for discussion at RRS and preparation of memo to EC re: 9 recommendations found in “Blackstart Resource Availability and Readiness in the Eastern and Western Interconnections, NERC and Regional Entity Staff Study, FERC Staff Observation” (the “Study”);
 - Brief discussion of what amendments are required to address joint compliance with RR B.5 and PRC 029 re: IBR facilities.
