 - 4.1. PRR List Outstanding – *D. Allen reviewed the list with RRS.*
 - 4.2. PRRs in Development
 - 4.2.1. PRR 153: “Sudden loss of fuel delivery system to multiple solar & wind plants” as Category I & II Design Contingencies in Table B-1 – *D. Allen reviewed status, no RRS comment.*
 - 4.2.2. PRR 155: Establish minimum interconnection standards for Large Inverter Based Resource (IBR) Generating Facilities based on IEEE Standard 2800-2022 – *R. Clayton/D. Allen reviewed most recent additions, noting the requirement for an As-built to facilitate confirmation that the facility meets the requirements of RR B.5. Procedural and Guidance documentation updates are also required to further establish that RR B.5 is required in addition to the NERC requirements.*
 - 4.2.3. PRR 157: “Mandatory Under-Frequency Load Shedding (UFLS) Design Requirements for Large Load Facilities” – *M. Paszek/David Allen reviewed most recent edits and requested a motion to bring PRR157 to EC for approval to post for the 45-day public comment period. Martin Paszek motioned, D. Interrante seconded, no objections, no abstentions, motion carried.*
 - 4.2.4. PRR 158: “Conforming Changes to Multiple Circuit Tower Exemption Language” – *B. Shanahan/David Allen reviewed the most recent edits and requested a motion to bring PRR158 to EC for Final Approval. B. Shanahan motioned, M. Paszek seconded, no objections, no abstentions, motion carried.*
 - 4.2.5. PRR 161: “Updates to RR C.7 regarding Exception Process Consistent with Changes to Policy 1, Section 5” – *D. Allen reviewed the redline, requested a motion to bring PRR161 to the EC for approval to post for public comment. D. Interrante motioned, M. Paszek seconded, no objections, no abstentions, motion carried.*
